3. Review of the open Change Requests

3.1. ISOC SCREW 315 "JEM -X dormant/safe mode in IOP/POD" (ISOC-ISDC ICD)

This editorial update of the ISDC-ISOC ICD was included in the version 2.4.2 of the ICD, issued two weeks ago. The Screw can be closed.

3.2. ISOC SCREW 317 "Minor updates" (ISOC-ISDC ICD)

This editorial update of the ISDC-ISOC ICD was included in the version 2.4.2 of the ICD, issued two weeks ago. The Screw can be closed.

3.3. ISOC SCREW 364 "Re-synch of observation after SATENG window" (POS-ICP ICD)

The software update was included in ISOC v 10.2. but the POS-ICP ICD has not yet been updated. The Screw remains open until the POS-ICP ICD is updated.

3.4. ISOC SCREW 365 "New belt exit/entry strategy" (POS-ICP ICD)

The software change was part of the ISOC v10 of mid-November and the document update in the POS-ICP ICD v 1.7. The Screw can be closed.

3.5. ISOC SCREW 378 "POINT_FIRST field in POD is a byte"

The software change was part of ISOC v10.2 and the document update in the ISOC-ISDC ICD v2.4.2. The Screw can be closed.

3.6. ISOC SCREW 384 "GCDE for AO2, step 1 implementation"

3.7. MOC GS-CR 10 "Remove MOUTP Stuff from the MOUT/MOUTP Appendix L"

The MOUTP description has not yet been removed from the Appendix L (although it has now been transferred into the ISOC-ISDC ICD). Change Request still open.

3.8. MOC GS-CR 44 "Change of GCDE for AO2"

3.9. MOC GS-CR 45 "Update of on-board background rejection criteria in DFEE"
